#### **INVESTMENT OBJECTIVE**

Long-term growth of capital through exposure to stocks deemed by the Adviser to be responsible investments, while mitigating volatility through a disciplined, risk-controlled, relative value investment process.

## **FUNDAMENTAL RESEARCH**

Stocks that meet certain environmental, social, and governance ("ESG") criteria established by the Adviser. Using an approach of quantitative modeling and fundamental research employed by Dana Investment Advisors in institutional products since 1999, the Adviser selects securities for the portfolio to generate alpha over the long-term.

#### STRATEGIC FOCUS

The Epiphany ESG Equity Fund holds a diversified portfolio of approximately 50 to 55 U.S. stocks deemed by the Adviser to be responsible investments. Risk controls are implemented throughout the portfolio construction process, and we look to add value with disciplined fundamental stock selection. The Fund includes a blend of characteristics designed to perform well in up, down, growth, or value markets.




