The Fund includes a blend of characteristics designed to perform well in up, down, growth, or value markets.

SECTOR ALLOCATION as of 03/31/25, subject to change



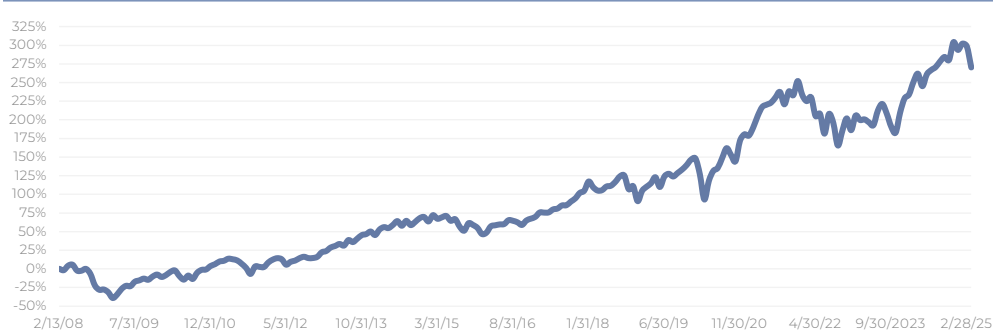

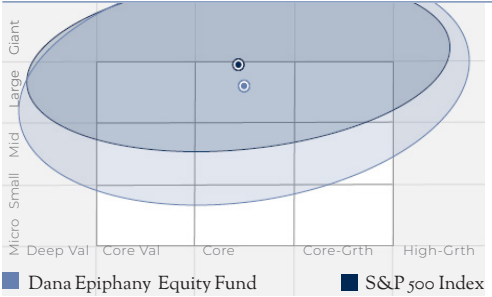

REPEATABLE INVESTMENT PROCESS

The investment process seeks to mitigate volatility utilizing several strategies including, but not limited to: sector-neutral weighting, equally weighted positions within sectors, and a maximum position size of 4%.

FIRM PEDIGREE AND HISTORY

Dana Investment Advisors was founded in 1980, is employee-owned, and manages \$8.7 billion as of 03/31/25. The firm has never wavered from our goal of providing above market returns while reducing volatility for our clients.
